In 1987, Joseph joined the U.S. Army's Judge Advocate General's Corps, fulfilling a four-year ROTC scholarship commitment. He gained litigation experience as a captain, prosecuting courts-martial, and through an appointment as a special assistant United States attorney, prosecuting civilians and military personnel in the U.S. District Court. Since joining Barnes & Thornburg in 1991, he has concentrated his practice in products liability defense, commercial litigation, and insurance coverage litigation. Joseph has represented a number of clients with substantial products liability exposure. He has handled litigation in a wide variety of jurisdictions, including Illinois, New Hampshire, Washington, Wisconsin, Missouri, Mississippi, Tennessee, Georgia, Michigan, Pennsylvania, Ohio and Virginia, in addition to Indiana.
