# President Trump Nominates Barnes & Thornburg Partner For Federal Judicial Post

President Donald J. Trump has nominated Barnes & Thornburg partner James R. Sweeney II to fill a judicial vacancy on the United States District Court for the Southern District of Indiana. If confirmed, Sweeney, an attorney and retired Marine Corps colonel and combat veteran, will serve as a district judge, filling the vacancy created when the Honorable Sarah Evans Barker took senior judge status.

Prior to joining Barnes & Thornburg, Sweeney served as a judicial law clerk for the Honorable John Daniel Tinder when he was a judge in the U.S. District Court for the Southern District of Indiana and for the Honorable James L. Ryan of the U.S. Court of Appeals for the Sixth Circuit.
