Guillaume Lacroix, Consul General of France in Chicago

Guillaume Lacroix became Consul General of France in Chicago on August 29, 2017. He holds diplomas from Institut d'études politiques de Paris and Université Panthéon-Assas. He speaks Swahili, a language he studied at Institut national des langues et civilisations orientales in Paris and in Zanzibar, Tanzania. He started his diplomatic career in 1997. He was assigned to the Department of African and Indian Ocean Affairs in Paris, then to the French Embassy in Dar es Salaam in Tanzania and to the French Embassy in Washington. He was also posted in two other diplomatic institutions: at the U.S. State Department as part of the Transatlantic Diplomatic Fellow program
