The unexpected visit from government investigators kicking off a civil or criminal investigation -- including investigations under the False Claims Act --- can keep in-house counsel up at night. This is especially true in the heavily regulated government contracting industry, where new and evolving regulations can make compliance an ongoing challenge for even the most ethical companies. Any government visit will be unannounced, and can have devastating effects on production, reputation and morale of a company. And that visit is certainly going to prompt attention and concern at the most senior levels of the C-suite. This means in-house counsel need to be on their toes more than ever.






