On Feb. 9, 2014, the IRS once again delayed enforcement of the employer mandate penalties of the Affordable Care Act for certain employers and issued final regulations clarifying how the employer mandate works. Many employers will need to re-engage in the process of determining how to comply with the employer mandate requirements in anticipation of the 2015 plan year. 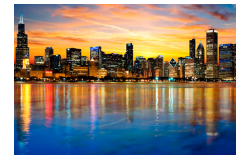

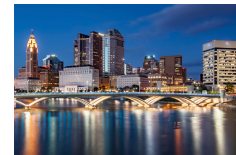

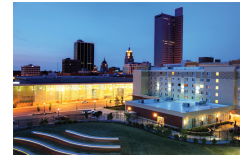
